Sub. : For issue of NOC to Hill View International School, 121, Society Area P.O. Road, Clement Town, Dehradun connectivity by Indian School Certificate Examination (ICSE) New Delhi.

Sir,

I have been directed to say that Hill View International School, 121, Society Area P.O. Road, Clement Town, Dehradun may be issued Indian School Certificate Examination (ICSE), New Delhi connectivity with following terms & conditions :

- (a) The school in Uttarakhand Council for the Indian School Certificate Examination/Central Board of Secondary School, New Delhi and for getting connectivity by both the above Board. The compliance of prescribed terms shall be essential.
- (b) The registered society of the school shall be renewed from time to time.
- (c) The management committee of the school shall be nominated a member by the Education Director.
- (d) The school shall allow admission to atleast 10% candidates of SC/ST category which are intelligent and they shall not be charged fee by the Uttarakhand Intermediate Education Board/Basic Education Board run by the School above named and they shall not be charged fee prescribed for them.

The institution shall not demand any grant from the State Government and if formerly the school has been indentified by the Intermediate Education Board and the school has connectivity the Central Board of Secondary Education,

New Delhi/Council for Indian Certificate Examination Board, New Delhi then from the date of getting connectivity with the above Education Board, their recognition and grant from the State Govt. shall automatically comes to and end.

- (f) The educational staff of the school granted help from the Educational Department the employee has not been granted fee and allowances less than granted to them.
- (g) The school/institution and the employee working there shall be made service rules and they shall be granted non-government higher secondary school less pay and salary.
- (h) The institution shall follow the instructions issued by the State Government from time to time.
- (i) That the record of the school shall be kept in proper registers.
- (j) The above terms shall not be changed, amended or extended without prior permission of the State Government.
2. That if in future it is found that the Education Board/Proposal have been defective and is not under the rules then the Director and controller/Additional Education Director shall be responsible for that.
3. The institution/school shall every year had deposit U-DISE (Unified District Information System In Education) in the office of Chief Education District Officer, which shall be necessary.
4. The school shall ensure compliance of all the rules of land use/ construction/order and if it is found that the above institution/school has taken illegal possession of any land, the State Govt. shall reserve the NOC issued to it.
5. If in the school the land/building is found not complying with the prescribed standard or if any dispute is found over the building/land the institution shall be fully responsible and the NOC granted by the State Govt. shall be withdrawn.
6. The map of the school building shall be the liability of the management committee and in case of non-grant of map sanctioned the NOC shall be rejected.
7. That the entire land/building of the school shall be got registered with the revenue department by way of lease deed for 30 years and shall be submitted to the education director and govt. within three months otherwise the NOC shall be rejected.

8. That the institution/school shall provide a certificate under Right to Education Act, 2011 that 25% Govt. Sponsor weak and neglected students have been given education in their school.
9. That it shall be obligatory on the part of institution and if at any time it is found that the institution has failed to fully comply with these provisions and have neglected in their compliance then the NOC granted by the State Govt. shall be rejected.

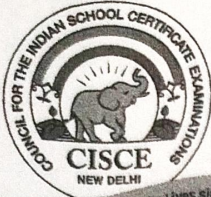


Dear Principal,


This has reference to your online request regarding change in the name of your School from Hill View International School to " Graphic Era Global School ".
